Navigate the CDS Declaration Instructions for Final Supplementary Declarations (FSD).

When completing a CDS Final Supplementary Declaration (FSD), it is recommended that you:

- Begin with the Declaration Category data set table in <u>Appendix 24</u> for the FSD.
- The Index list for the 4-digit Procedure Code in <u>Appendix 1: DE 1/10: Requested and Previous Procedure Codes</u> should then be used to identify the appropriate procedure code to be declared in DE 1/10.
- The <u>DE 1/10 to DE 1/11 Correlation Matrix</u> should then be used to see which Additional Procedure Code is permitted for use with the 4-digit Procedure Code.
- The Index List for the Additional Procedure Code in <u>Appendix 2: DE 1/11: Additional Procedure Codes</u> should be used, from the list of those permitted with the DE 1/10 Procedure Code, to identify any supplementary conditions that apply to the Additional Procedure Code.
- Examine <u>Appendix 4: DE 2/2: Additional Information (AI) Statement Codes</u> to identify any additional information to be declared, as defined in the Procedure and Additional Procedure Code completion instructions.
- The main <u>CDS Declaration Completion Instructions for Final Supplementary Declarations</u> should be used in conjunction with the additional completion instructions provided in <u>Appendix 1: DE 1/10: Requested and Previous Procedure Codes</u> and <u>Appendix 2: DE 1/11:</u> <u>Additional Procedure Codes</u> to complete the FSD.
- Where the completion rules for a specific data element in <u>Appendix 1: DE 1/10: Requested</u>
 and <u>Previous Procedure Codes</u> and <u>Appendix 2: DE 1/11: Additional Procedure Codes</u> specify
 different rules to the main <u>data element completion guidance</u> or other appendices, the rules
 specified in Appendices 1 and 2 take precedence.
- Complete the FSD with continued reference to the appropriate Appendices (please see the <u>Appendices Index list</u> for details).
